### **Speakers**

### Lloyd Vas:

Lloyd is the longest serving team member of the Carbon Market Institute. Lloyd has been involved with the Institute since the transition from the Asia-Pacific Emissions Trading Forum (AETF). He has extensive knowledge and experience in the carbon market including carbon trading and project financing with Camco in London and Beijing. Since 2009, his Australian work experience involves positions held with Innovative Carbon, the Victorian Government's Carbon Market Development program and the start-up of CMI.

#### **Patrick Hearps:**

Patrick Hearps is a Project Director and Research Fellow in Energy & Transport Systems at the University of Melbourne's Melbourne Energy Institute. He is also a research director and partner at Beyond Zero Emissions, a not-for-profit research and education organisation known for its work designing and implementing a zero emissions economy for Australia. Its goal is to transform Australia from a 19th century fossil fuel based, emissions intensive economy to a 21st-century renewable-energy-powered clean-tech economy.

#### **Nicole Brown:**

Nicole is the Program Manager for the EIANZ Staged Training for Environmental Practitioners, or "EIANZ STEPS" initiative which aims to support and develop people through their early career so they can obtain the proficiencies needed to become skilled and ethical practitioners. Nicole has previously held roles in stakeholder management, community engagement, human resources and organisational development with Parks Victoria.

#### Kate Sargeant:

Kate's interest and passion relates to improving the management of land while improving the livelihood of farmers and the sustainability of agriculture in Australia. She has had eleven years' experience working in research, development and extension (R,D&E) for the Department of Environment and Primary Industries in Victoria, specialising in pasture agronomy, grazing management and livestock (beef and sheep) production systems. She currently leads a national RD&E project, EverGraze. As a CRC project, EverGraze is a collaboration between two farmer levy funded industry bodies, federal government, three state government agencies, a university and farmers. The challenge is to design, test and implement livestock systems based on perennial pastures which significantly increase profit while at the same time meeting environmental and risk management objectives. Since 2003, a multidisciplinary team of researchers, service providers and farmers have combined a set of principles with modelling, farm systems research, on-farm demonstrations, case studies, decision support tools and training to develop meaningful and evidence-based messages for farmers. The most recent and significant achievement of EverGraze is development of web-based regional information packages which link these elements together and make them available to a multilevel audience (farmers, service providers, researchers and government). ### **Speakers**

#### Glenn Davidson:

With a long history of professional development facilitation, group training and consultancy to the education, business and community sector, Glenn has for the past 5 years worked as Director of Learning Management with Carbon Training International.

This role at CTI entails the development of face to face and eLearning courseware, resources and learning strategies. The role also has Glenn instrumental in the development facilitation techniques and content knowledge extension along with identification of new service and program delivery opportunities, especially in the international market. A developing role for Glenn lies in the instructional design of Carbon Management courses for mLearning and MOOC application.

In the completion stage of a doctoral thesis examining Adult Learning engagement and its application to the rapid acquisition of skills and knowledge for a Low Carbon transition, Glenn is well versed in contemporary learning theory for adults. This theoretical and academic background has been instrumental in synergising quality learning outcomes via its integration with a well established practical teaching experience.

He is currently a panelist on the Education Advisory Panel of the Carbon Markets Institute and Communities of Practice advisor with the Carbon Managers Institute of Australia and New Zealand. Glenn also serves as a Head Reviewer of international courseware for Epprobate Quality eLearning Label.

#### **Professor Gavin Mudd:**


Gavin works in the Faculty of Engineering at Monash University as a Senior Lecturer in Environmental Engineering. Gavin graduated from Environmental Engineering at RMIT at the end of 1994. He began work in the Latrobe Valley in early 1995, and started a PhD through Victoria University in mid-1995 looking at the environmental impacts of coal ash from power stations. After 1.5 years at the University Queensland as a Research Fellow in Mine Waste Hydrology, and about 1.5 years as a consultant (mostly based in Kakadu National Park advising indigenous groups on uranium mining impacts), Gavin joined Monash in May 2003 to help with the Environmental Engineering course. In early 2006, he was appointed Course Director and continues to play a very active role in teaching Environmental Engineering and promoting the course. Gavin's research interests concern sustainability, mining, groundwater and environmental impact assessment and management.

### **Gordon Young**

Gordon Young is an environmental consultant with experience across many aspects of the sustainability field, including energy, water, waste and transport. He has recently completed a one year placement in remote Indonesia, conducting environmental education as part of the Australian Youth Ambassadors for Development program, a branch of AusAid. Gordon will present on both his experiences in Indonesia and with the AYAD Program itself; challenges faced, solutions to these problems, and opportunities for Students and Early Professionals keen to work in the development context.
