**To be eligible for Nomination, you must be a current financial Ordinary (Full) Member, Fellow Member, Honorary Fellow Member or Honorary Life Member of the Environment Institute of Australia and New Zealand Inc. The two Members or Fellows endorsing the Nomination must also be current financial members. Associate Members or Student Members are not eligible to vote and cannot endorse nominations.**

- be signed by the candidate;
- be signed by the endorser number 1 (who must be a financial member as defined above); and
- be signed by the endorser number 2 (who must be a financial member as defined above).

In accordance with EIANZ By-law 6 (32) if a statement exceeds 200 words in length, the Returning Officer will exclude all words after the 200th word.
