# 1. From the President

It has been a pleasure and privilege to be the President of the FNQ Branch of EIANZ from 2012-14. The Far Northern Division membership comprises 101 members and includes environmental practitioners from Australian, state and local government, public companies, educational institutions, utilities, consultancies, mining and construction companies and law firms.

The highlights for the FNQ Division have been working with a great committee of people with diverse skills, experience and passion for the environmental profession, organizing some great professional development and social events in Cairns, Townsville, Mackay and Rockhampton and updating the website and communicating with members. I believe that the FNQ Committee has achieved its objectives for 2013-14.

The objectives of the Far Northern Division include:

- advance ethical and competent environmental practice;
- promote environmental knowledge and awareness;
- facilitate interaction among environmental practitioners; and
- highlight information on emerging and important environmental issues
- In far north Queensland, key issues include:
- port expansion along the Queensland coast;
- clearing of native vegetation;
- streamlining and amendments to environmental legislation;

- dissemination of information and capacity building; and
- climate change.

### 4. Governance

The FNQ Division provided advice to the EIANZ Executive on several key Governance documents such as the EIANZ Corporate Plan, Fellowship, Training, Strategy and Plans.

FNQ committee meetings had an agenda and minutes were taken.

We advertised and employed a part-time secretary using a standard contract and procedures from EIANZ Central Office. We employed Carol Marshall who has done an outstanding job for the year. She has decided not to continue in 2014/15 so we advertised the position to all members in May 2014.

The financial position of the FNQ Division (Credits in Bank) at June 2013 was \$14,151.24 and at June 2014 was \$13,188.17. An Annual Financial report is attached.

### 5. Communication

A highlight has been the update of the FNQ information on the website with information on the committee, issues, past events. Several articles were included in the SEQ Newsletter and the EIANZ e-newsletter The Environmental Practitioner. We did email mailouts and Linked-in updates.

We produced one media release on 4 September 2013 on the Endangered Species Forum

We provided advice to the government and community on several environmental issues.

A challenge is that FNQ members are widely dispersed over a broad geographical area which makes face to face meetings and communication more difficult (than a major city).

### 6. Building Relationships

The FNQ Division Committee has been working towards the delivery of a range of events and professional development opportunities throughout the North Queensland region. We have been investigating topical issues and suitable localities to service the whole of the FNQ Division member base.

FNQ Division members in Cairns, Mackay and Rockhampton would like to become more involved with events and professional development and networking opportunities. We have asked members in these areas to suggest events which we are happy to support with organizational skills and some funding.

FNQ Division continues to develop relationships with other organisations and associations, including the JCU, CSIRO, AIMS, AICD, NQCC, Wet Tropics, GBRMPA and providing opportunities to share events and broaden our contacts base.

## 7. Plans for 2014/2015

The FNQ believes that 2013-14 was a good year with an ongoing President, Secretariat and Councilor and several ongoing committee members. In the coming year the President is standing down and our paid secretariat is finishing up. The FNQ Division plans to deliver at least four professional developments, networking and social events for the Environmental Profession of Far North Queensland throughout the 2014/2015 year. Examples of the types of events we believe that the members and community would like us to organize on their behalf are presence at JCU open days/guest lectures; host several discussion events on emerging or new environmental

policy/management/technologies, training on legislation or environmental management tools and techniques.

We plan to vote at the AGM on the boundary between FNQ and SEQ divisions and how we can best work together.
