GUIDELINES FOR CONTRIBUTORS

The Australasian Journal of Environmental Management (AJEM) is aimed at a professional multi-disciplinary readership in environmental policy and practice. The majority of articles focus on Australia and New Zealand, but international articles of interest to the readership may be considered. Articles should deal with current practice, research and new initiatives in environmental management. These will be refereed before publication. They should be written in a manner accessible to our general readership. Specialist or highly technical material would be better placed elsewhere. Contributions may be:

- substantive original articles between 4000 and 6000 words, including an abstract no longer than 200 words that captures key findings. Please also provide four to six keywords that are not included in the title
- short reports of around 3000 words
- reviews of books and other relevant material between 400 and 1000 words.

Please contact the editors before preparing reviews as unsolicited material may not be accepted.

Letters to the Editor responding to, or commenting on, issues raised in published articles or reports are welcome, and will be published subject to editorial discretion. AJEM will not publish articles or reports that have been formally published elsewhere.

On the front page of articles and reports give: (1) the title; (2) first and last names of authors, the organisation with which they are associated and its address; and (3) the contact author's email, postal address and phone number.

Use A4 size pages with 1.5 spacing.

Email your manuscript to the Editors at ajem@uq.edu.au . The editors will acknowledge receipt and provide a reference number, which should be used in all correspondence.

Style and referencing

Please consult previous issues for the style of headings. Spelling should conform to the Macquarie Dictionary. For style and referencing follow the recommendations in the current (2002) edition of the *Style manual for authors, editors and printers* published by John Wiley & Sons Australia Ltd. Use the author-date referencing system, with references presented in an alphabetical list at the end of the article, for example:

The accuracy of the method is supported by the findings of Smith (2006a) and Jones et al. (1999), although some applications have raised questions over its effectiveness during periods of low flow (e.g. Barker & Gibson 2004).

According to relevant state policy, this review is to be completed by mid-2008 (NSW DEA 2007), but some participants believe this deadline may be extended (F Thomas, PTL and Co., 2007, pers. comm., 23 March). This process is in addition to all emission permits being issued in accordance with s. 5(c) of the *Environmental Quality and Control Act 1996* (NSW), and subject to appeal under s. 7 of that Act, as established by Cooper J in the Fitzpatrick (1997) case.

In the case of journals not numbered consecutively throughout an entire volume, please identify the issue numbers: for example, vol. 12, no. 4, pp. 26-39 or vol. 10, April, pp. 3-14.

For multiple works by an author in different years, arrange sequentially; for multiple works by an author in one year, use 2006a, 2006b, etc. in the text and reference list.

Reference to direct quotes must include the page number(s) from which the quote comes, for example (Smith 1999, p. 35). Only essential footnotes are to be included and the material

Tables, figures and photographs

must be kept to a minimum.

Tables, figures and photographs must: (1) not be in colour; (2) be in the same style as the written text and conform to the layout recommended in the *Style manual for authors, editors and printers;* and (3) be of high quality suitable for reproduction.

Place tables, figures and photographs within the text, but also provide original copies in a separate file (i.e. photographs in .tif, .eps, or .jpg; and tables and figures in excel, powerpoint, etc.). Information in tables and figures must be kept to a minimum, consistent with clarity.

Copyright and permission to reproduce

Authors are responsible for obtaining permission to reproduce copyright material (such as textual quotations and diagrams) from other sources, and are required to sign an agreement for the transfer of copyright to the Environment Institute of Australia and New Zealand. This agreement provides authors with certain rights to use and disseminate their own work.

Proofs and offprints

Page proofs will be sent to the contact author. They should be returned to the editors as soon as possible to avoid delaying publication.

Authors will receive a pdf copy of their published article and a free copy of the relevant AJEM in lieu of offprints.
