Orderly transition or chaotic disruption?



Governments are attempting to minimise the impacts of climate policy on the BAU economy, however...

In the absence of credible government policies to reduce emissions in a measured and predictable way (orderly transition);

Communities and civil society will look for other ways to achieve abatement.

This may ultimately be much more disruptive to the economy and government authority.



From 'top-down' to 'bottom up'



Response:

- little community confidence in government or 'top-down' measures
- Review of strategy employed by civil society and environment groups
- Shift in approach to focus 'at source' (keeping fossil fuels in the ground)

WA's domestic GHG **Emissions**



Total current WA GHG emissions ~80 MT p/a


New offshore LNG projects will increase this by 1/3

Wheatstone LNG >10 MT p/a (no effective abatement conditions) 8.7MT p/a **Browse FLNG** (no abatement conditions at all – cancels out entire ERF abatement) **Prelude FLNG** 2.3MT p/a (required offsets reportedly sold by proponent) **4 – 6.7** MT p/a **Gorgon LNG** (some CO2 reinjection required - if feasible)

This is only the emissions from processing the gas!




Lifecycle emissions from Australia's fossil fuels compared with 202 carbon budget



WA onshore gas resources


- One of the world's largest onshore gas reserves
- Estimated 280 trillion cubic feet of recoverable gas = 200 times Australia's annual gas use
- Require an estimated 100,000+ fracking wells
- Could produce over 20GT of CO2 (domestic + international



Gas fracking – Regulatory free zone!

- No EPA assessment of fracking (Nationals MP's saying EPA 'abrogated responsibility')
- Commonwealth 'Water trigger' does not apply to shale gas in WA
- No single government agency in WA responsible for protecting groundwater quality & no standards in place
- Fracking effectively exempt from pollution control regulations
- Regulator (DMP) is also promoting development
- DMP requirement: 'As low as reasonably practicable' (ALARP)
- No access to monitoring data by community
- Government review found DMP's Environment Management Plans 'unenforceable'
- Zero controls on GHG pollution

Western Australia's first Gasfield Free Community, Central Greenough, will celebrate its new status with an official declaration ceremony in Greenough Hamlet on Sunday

Gasfield Free Communities is a grassroots movement against gas mining and exploration.

Midwest Shires move to protect land and water from gas fracking



Conservation groups, farmers and community organisations have congratulated two Shires in the WA Midwest for adopting policies designed to protect farming, groundwater and community health from the impacts of gas fracking planned in the region.

Backed by Western Australia's peak environment group, the *Clean Water Healthy Land Alliance* is supporting local communities to protect their land and water from planned gas fracking developments.

Speaking on behalf of the alliance, CCWA Director Piers Verstegen said "Communities across the Midwest are working together to defend their farms and groundwater which is under serious threat from widespread shale gas fracking planned in the region"








Cost of abatement?


\$0.5 - 1M cost of advocacy to keep WA's onshore gas in the ground
