ANDREA ZAMBOLT, MEIANZ CENVP | CANDIDATE: VICE-PRESIDENT (AUSTRALIA)

I am a Principal Environmental Scientist and have over 23 years of experience in the environment industry. I have led multi-disciplinary environmental teams for large infrastructure projects for road, rail, power, water treatment and pipelines.
