### How to Make a Nomination

To submit a Nomination, you will need to complete the Nomination Form below, providing a written statement on how the Nominee company meets the criteria, and attaching any additional supporting material. Self nomination is permitted. Nominations can be submitted digitally as a printable pdf file using Adobe Reader (max 10MB) and sent to: [office@eianz.org](mailto:office@eianz.org) [Note: EIANZ Merit & Service Awards in e-mail title]. Alternatively nominations can be posted or faxed. See details at the end of this form.

### Judging of Nominations

Nominations for the Small/Medium for Outstanding Professional Service will be judged by a Committee of senior environmental practitioners, all members of the Institute

Entries will be excluded from judging if found to include false or misleading information. Self- nomination is permitted. Nomination fees for Small/Medium Company Award in 2010 are \$90. Nomination fees provide partial cost coverage for Award administration. Nominees will be sent a Tax Invoice for payment upon receipt.

### Award Criteria

Provide a short summary of how the Nominee company contributed to the provision of outstanding services to the Environment Industry (500 word maximum). Nominations can be based on one or more instances that have demonstrated the delivery of outstanding services and the achievement of exceptional environmental outcomes by a company with less than 100 employees.

Nominations can be submitted electronically as a printable pdf file (max 10Mb uncompressed), with all pages of size A4. Written nominations should not exceed 5 A4 pages. Additional supporting materials may be provided within the allowable file size limit. Nominations will also be accepted by mail or fax.

Nominations should address the following criteria in terms of how relevant projects undertaken by the nominated company demonstrate the provision of exceptional environmental outcome:

- **Significance** - the scale, environmental importance, geographic influence of the project.
- **Leadership** - how the project has provided leadership in environmental management through its replication, or through communication of outcomes and techniques beyond the project.
- **Innovation** - How has the project demonstrated innovation through the application of new techniques or use of new technologies, through interdisciplinary/multi-disciplinary teamwork, or through investment in research and development.
