EIANZ SA Division Presidents Report 2024 AGM

SA membership overview

SA's membership at the end of June 2024 was 105, compared to 100 at 30th June 2023. This makes up 4.82% of the overall EIANZ membership of 2,180.

As of 30th June 2024 (noting this includes a few members that expired 30th June and assumed to have renewed since, alas numbers are slightly off, i.e. Maria Pedicini is one of these members who is very much expected to have renewed):

- Honorary Life Members: 2
- Fellow Members: 5
- Honorary Fellow Members: 0
- Full Members Retired: 3
- Full Members, 15 years+ of membership: 20
- Full Members, 10-14 years of membership: 15
- Full Members, 5-9 years of membership: 13
- Full Members, 1-4 years of membership: 21
- Full Members, new members for 2023-2024: 9
- Associate Members: 11
- Student Members: 8

Of the 63 CEnvP's in SA (down from 66 last year), 22 are EIANZ members:

- General Certification: 11 (of 26 in SA)
- Ecology Specialist: 1 (of 1 in SA)
- Impact Assessment Specialist: 3 (of 4 in SA)
- Site Contamination: 7 (of 32 in SA).

The 2023-24 SA Division Committee were thanked for volunteering their time and energy to meeting monthly to brainstorm, plan and coordinate events and activities. It was acknowledged that significant effort is required to coordinate our events, many of which have been in the works for 6-18 months before they are held purely to lock in suitable dates, times, locations, and appropriate timing (ability to publicly release information).

A brief overview of planned events was highlighted, including:

- Nature Repair/Significant Environment Benefits presentation scheduled for September, with Hugh Possingham and Tanya Schneyder from the Native Vegetation Council
- Tour of the Integrated Waste Recycling Facility at Wingfield as part of National Recycling Week
- Conference day (or half day) anticipating student and early career involvement, with a panel discussion (topics to be refined, but likely about career progression opportunities in SA).

It was highlighted that the Committee are always willing to hear about member suggested events and activities, not just the types of presentations, but also extending to tours, events, panel discussions, as well as the logistics that suit our members – time of day/week, etc, and opportunities for online attendance where practical. Members were also encouraged to think about our members that should be nominated for Fellows and Honorary Fellows (nominations due 19th August).

The contribution of Nathan Zeman as President was highlighted, acknowledging that Nathan is absent due to taking a very much well-earned holiday during his long-service leave. Before leaving, Nathan indicated his willingness to remain on as a SA Committee Member. A proper celebration and acknowledgement of Nathan's contribution as President will be made at the next event he's able to attend in person.

All members were thanked for their involvement, contribution, and dedication to being great environmental practitioners, and making a contribution to environmental work in SA.

<u>Treasurer Summary – SA Division - financial year ending 30 June 20242</u>

<u>Treasurer Summary – SA Division - financial year ended 30 June 2024</u>

Total income for the 2023/24 financial year was \$5,702 and total expenses were \$1,537 resulting in a net surplus of \$4,165. This result is consistent with the previous financial year.

The Balance Sheet at the end of June 2024 shows an equity position (net assets) of \$26,908.

At 30 June 2024, the division had 105 active members consistent with last year, comprising 76 Full members, 3 Full members (retired), 3 Fellow members, 1 Fellow Member (retired), 2 Honorary members, 12 Associate members`,) and 8 student members.

In 2023/24 our chapter /division committee costs were \$790, comprised of \$419 for the 2023 AGM, and \$371 for the 2023 end of year event.
